COMMUNITY POOL & SPA

With the warm weather upon us we would like to take the time to remind residents of the pool/spa rules regarding pool hours and noise. We appreciate you letting the members of your household know about the importance of abiding by the rules listed below.

Pool Hours

1. The pool is open between the hours of 6:00 a.m. and 11:00 p.m. only. No admittance after hours. Pool area facilities are closed between the hours of 11:00 p.m. and 6:00 a.m.
2. While it is understood that the pool, as a social and recreational area, will have an inherent amount of noise and activity, Residents and guests must always be considerate and respectful of nearby Residents particularly prior to 8:00 a.m. and after 9:00 p.m.
3. When the gate is locked so that Resident keys will not allow access, the pool is closed. The pool may be closed occasionally for maintenance or regulatory reasons temporarily prohibiting use of the pool by any Resident. Climbing over the fence in order to enter the pool area is not allowed and will be considered trespassing. Trespassers may be prosecuted.
